## Town of Winhall Selectboard Meeting Minutes for Wednesday, July 20, 2022

PRESENT: Stuart Coleman; Bill Schwartz; Julie Isaacs; Lissa Stark (Town Administrator); Lucia Wing (Secretary), Trevor Dryden (Highway), Scott Bushee (Facilities)

**CALL TO ORDER:** Coleman opened the meeting at 5:30 PM at the Town Hall in Bondville.

**PUBLIC COMMENTS:** (None)

POLICE DEPARTMENT REPORT: (No report)

## **HIGHWAY DEPARTMENT REPORT:**

Dryden reported he had met with Steven Morse relative to water runoff from the Access Road onto the end of his driveway; a solution was underway; sand delivery was in progress; Dryden had replaced a culvert on Signal Hill Road- others were scheduled; no response to date on line striping; no State hydraulic study to date for the Access Road; and no response from Fleming relative to the Benson Fuller intersection. Dryden reported that speed bumps on Lower Taylor Hill Road would cost \$120 per section; Dryden would also install a digital speed sign approx. half way down Lower Taylor Hill to help slow traffic; guard rails had been installed on the Access Road; and Dryden would check out the Beechwood Ridge entry.

#### **ACCESS PERMITS:**

After review, the Selectboard approved an access permit (no culvert necessary) for Jessica Marullo, #18 Windtree Road; approved a driveway relocation for Mike Webb on Forest Haunts road which required an 18" culvert; approved an access permit for Richard Voyentzie, #4 Summit View Road (High Meadow)- discussion followed relative to the 911 number; and approved replacement of an 18" culvert for Elena Bischoff, #60 Lake Road; *motion by Isaacs; seconded by Schwartz; unanimous.* 

## **FACILITIES REPORT:**

Bushee reported he had met with Sparky per electrical at the Fire Station; A.S. Clark & Sons had replaced the pump chamber at the Fire Station; discussion followed relative to seeding the area. The screen door for the Library had been delivered; the Community Center power washed with a few addons in progress; and he was establishing a "bag policy" at the Transfer Station.

## **EXECUTIVE SESSION:**

At 6:10 PM the Selectboard voted to go into executive session to discuss Highway personnel matters; *motion by Isaacs; seconded by Schwartz; unanimous.* At 6:20 PM the Selectboard voted to come out of executive session; *motion by Isaacs; seconded by Schwartz; unanimous.* Out of executive session, no decisions were made.

## AWARD TOWN COMPUTER SYSTEM:

After review, the Selectboard awarded the bid to E-Enable Inc. Bennington, Vermont for \$19,384 (no server); *motion by Isaacs; seconded by Schwartz; unanimous*. The other bid was submitted by Northshire Network Inc. @\$73,000 without a server and \$103,000 with a server; discussion followed relative to the two (2) bids.

#### MUNICIPAL WASTERWATER: DISCUSSION:

FYI: State funding was potentially available for municipal wastewater projects. The Town Administrator had contacted the WRC; waiting on responses from State agencies; discussion followed.

#### **SHORT-TERM RENTALS:**

The Planning Commission had formed a 3-person committee to draft language for an Ordinance relative to short-term rentals.

**COMMUNITY CENTER & HEALTH UPDATE:** A \$250 gas card had been dispersed to a family with medical needs.

**TOWN-WIDE REAPPRAISAL:** FYI: RFP was out to bid; due August; no response to date.

#### **COMMUNITY UNION DISTRICT**

Schwacke had sent correspondence relative to joining Bennington versus Deer Valley re: expanded broadband in Winhall; Schwacke would keep the Selectboard informed.

ADMINISTRATIVE & CORRESPONDENCE: The yearly audit was underway.
