### Town of Winhall Selectboard Meeting Minutes for Wednesday, November 1, 2023

<u>CALL TO ORDER</u>: Schwartz opened the Selectboard meeting at 5:30 PM at the Town Hall. The Selectboard added the Liquor Board Hearing to the agenda; vote unanimous.

## LIQUOR CONTROL BOARD:

The Selectboard closed its meeting and opened the Liquor Board hearing at 5:40 PM. After review, the Liquor Control Board approved a 1<sup>st</sup> and 3<sup>rd</sup> Class liquor license for HJC LLC; *motion by Isaacs; seconded by Schwartz; unanimous.*

## **POLICE DEPARTMENT REPORT:**

The Selectboard & Chief Tienken reviewed the monthly police report for October to include traffic tickets and warnings; false alarms; animal control issues; property watch matters; DUI arrests; motor vehicle incidents; and medical & pedestrian assists in and around Winhall and the Stratton Mountain Resort. Chief and the Selectboard reviewed the 2023 Police Survey. Discussion followed about survey results relative to police competency, visibility, presence, safety, traffic enforcement, relationships with the community, what was liked most about the Department, and what could be improved. The results were overwhelmingly positive. Chief reported there had been several DUI arrests over the past week.

### TOWN TREASURER REPORT:
