Greetings from your Winhall Police & Rescue Department.



We are in the process of gearing up for Winter weather and we hope that you are doing the same. There are many important steps to take to make sure that your vehicle is ready for the cold weather.

Here is a list of things to consider:

- Make sure you have your vehicle tuned up and checked for any mechanical issues that might arise
 during the winter season. Make sure that all fluid levels are checked as well. Understand the
 safety features with your vehicle, such as antilock brakes and stability control and how each reacts
 on slippery surfaces. Look closely at your tires, inspecting for sufficient tread and appropriate tire
 pressure. Consider upgrading to snow tires if possible.
- Keep items in your vehicle that can help you if you are stranded in an emergency during the winter months. Items may include a shovel, broom, ice scraper, jumper cables, flashlight, warning devices or flares, charged cell phone, water, food and blankets.
- When planning on going out into wintery weather, be sure to check forecasts and road conditions. Leave early, drive slowly and allow enough time to get to your destination safely. Remember that your GPS in not foolproof and can sometimes lead you down roads that are not maintained or safe for winter travel.
- Make sure everyone in your vehicle is wearing their seatbelt. Also, be sure that children are buckled up in an age appropriate car seat, booster seat or seat belt.
- Winter driving can be difficult all by itself. Avoid using your cell phone while driving and always drive sober. Both alcohol and drugs whether legal or illicit can cause impairment.
- Slow down! It is harder to control or stop your vehicle on ice or snow covered roads. Regardless of whether you own a 4-wheel drive or all-wheel drive vehicle or have aggressive snow tires you can still lose control of your vehicle. Remember that speed limits are for ideal driving conditions. Winter driving conditions are not ideal.
- Don't crowd plow trucks. Plow trucks travel slowly, make wide turns, stop often and exit the road frequently. It may also be difficult for the driver to see your vehicle. If you find yourself behind a plow truck, use caution, and stay behind or pass in a safe location.

Hopefully these tips will help you prepare for the upcoming season. As always, don't hesitate to reach out if you have any questions or concerns.

The highway department would like to remind everyone that the town has a no parking policy on the town roads from November 1 until May 1 with a \$50 fine and vehicles will be towed. The reason we have this parking policy is because it is difficult for the highway trucks to get down the roads with the size of the trucks we use. The plow is a total of 11 feet long and the wing on the side of the truck is 10 feet long so the total width of the truck going down the road is 12 feet wide. Kendall Farm Road Town Forest Parcel ~ Benefits of Planned Timber Harvests

1. Recovery of Imminent Losses Through Harvesting of At-Risk Trees:

- a. This forest contains a significant proportion of good-quality, high-value, and at-risk ash trees.
- b. Ash tress are threatened by "Ash yellows" and the emerald ash borer. (confirmed emerald ash borer infestations nearby)
- c. Once infected, these trees quickly decline and lose value.
- d. Harvesting now will remove much of the at-risk ash sawtimber, thereby recovering imminent / likely losses.

2. Improve Future Value of Forest:

- a. Low-quality, diseased, mature, and over-mature trees will be targeted for removal.
- b. The best-quality and most vigorous trees of desirable / high-value species will be favored for retention in the forest
- c. Crowding will be reduced to allow for increased rates of growth, which will lead to increased value accretion.
- d. By removing low-quality, diseased, and mature sawtimber, we will create more growing space for the best quality and vigorous trees. This will improve growth rates and value accretion into the future.

3. Improve Wildlife Habitat Diversity:

- a. This harvest will use the "single-tree selection" and "group selection" methods.
- b. When used together, these two methods will create gaps of varying sizes throughout the canopy of the stand that will function to promote the establishment of seedlings and saplings and allow for the growth of already established, but immature trees.
- c. Young seedlings and saplings serve as browse for many mammals and birds and provides essential nesting habitat and cover for many species. The structural diversity created through this harvesting provides desirable habitat for many migratory birds.
- d. The establishment of seedlings / saplings, especially in group openings will provide excellent browse and cover for a variety of wildlife species. The general increase in structural diversity will create more suitable habitat for a wider variety of wildlife species.

4. Improve Forest Health and Resiliency:

- a. The north-eastern forests face an increasing number of threats.
- b. These include pests and pathogens, more severe and more frequent weather events, and invasive species to name a few.
- c. This harvest is designed to remove more susceptible and high risk trees, increase species diversity, create a cohort of young trees, and improve the overall health and vigor of the forest.
- d. Improving species diversity, creating a wider variety of age-classes, and focusing growth on the most vigorous and healthy stems will help make this forest more resilient in the face of current and future threats and more capable of recovery.

5. Create Recreational Potential:

- a. The current recreational trail system is extremely limited and provides access to only a small proportion of this forest.
- b. Harvesting will result in the re-opening / creation of a network of primary and secondary skid-trails
- c. A portion of these trails could be further developed into a network of looped-trails serving primary purposes for a variety of activities including hiking, skiing, birding, mountain-biking, forest management education, etc.
- d. Forests of this type typically require 15 20 years of recovery time before a re-entry for harvesting is justified
- e. Harvesting will create a base network of trails while also providing income to support future recreational development. Involvement of a municipal recreational board / committee, partnerships with recreational organizations, as well as the availability of grants, should be explored.
