***Request for Proposals ~ Foundation for Electronics Storage Shed***

**Introduction**

The Town of Winhall is seeking proposals from qualified contractors for the site excavation and concrete foundation for a new Transfer Station Electronics Storage Shed for the Town of Winhall. The existing Transfer Station is located at 66 Old Town Road.

A mandatory pre-bid site meeting will be held at 66 Old Town Road in Winhall on **Monday, June 12, 2017 at 10:00AM** for all interested contractors. Proposals will only be accepted from contractors that attend the pre-bid site meeting.

**Project Summary**

The project consists of site excavation work and then the pouring of a concrete foundation measuring 30' long by 24' wide. The walls should be poured concrete measuring 6'5" high.

**Responses to this Request for Proposals should consist of:**

- 1) A letter expressing interest in working with the Town of Winhall on the project.
- 2) Identification of key personnel assigned to the project and qualifications relevant to the project.
- 3) A description of the proposal, including detailed drawings/plans, a description of the approach to be taken toward completion of the project, a proposed schedule that indicates project milestones and overall time of completion, and any insights into the project gained as a result of developing the proposal.
- 4) Proposed fee structure with detailed explanation of projected milestones and billing frequency.
- 5) Any other information applicable to the project.

**Period of Performance**

Work shall commence upon the date that said contracts are fully executed; estimated start date to be August 1, 2017 and work shall be completed no later than November 1, 2017.

**Submissions**

Proposals from interested parties must be received by the Winhall Town Administrator no later than **1:00PM on Friday, June 23, 2017**. Submissions must be e-mailed to [townadmin@winhall.org](mailto:townadmin@winhall.org). Contractors are responsible for confirming receipt of proposals by the Town of Winhall. Proposals will be evaluated based upon the contractor's experience, background, and ability to perform the requested services at an affordable price. Cost will not be the sole determining factor in the award of this contract. The Town of Winhall reserves the right to reject any proposal that does not meet the criteria specified in this RFP, is received after the deadline, or is not complete.
